The facility occupied one 4-storey building as production and office, and one flat building as warehouse and lunch area. Neither canteen nor dormitory was provided in the factory. The total construction floor area of was 4500 square meters.

There were a total of 152 employees (121 productive employees and 31 non-productive employees) with 47 male and 105 female employees. The youngest employee noted during this audit was 19 years old.

The factory adopted a finger scanning system to record working hours of production employees. Per management and document review, all production replayees worked in 1 shift: 8:00-12:00 and 13:30-17:30. Wages of employees were paid at zound 30th of the next month by cash. Per payroll review and interviews with management and employees, all production employees were paid at zound 30th of the next month by cash. Per payroll review and interviews with management and employees, all production employees were paid at by hourly rate.

During the audit, employees' time and wage records were sampled as follows for working hour and wage testing: each 15 samples from current paid month of July 2019, random month of May 2019 and June 2019. And 5 additional time records from current complete but unpaid month August 2019 were

According to the sampled time records, it was noted that the maximum overtime hours were 2 hours per weekday, and 84 hours per month. Employees worked consecutive 6 days at most.

According to the sampled payroll records, it was noted that all employees were paid at least CNY 12.07 per hour during lested period, which was not less than the local minimum wage CNY 2100 per month. Employees overtime hours worked on weekdays, weekends and holidays were paid with 150%, 200% and 300% of employee's normal wage, which were in compliance with legal requirement.

According to the social insurance payment receipt provided by factory management, it was noted that only 141 out of 152 (92,76%) employees were provided with accident, medical, unemployment, maternity, and pension insurance in August 2019. Besides, factory provided 100 employees with commercial accident insurance from December 30, 2018 to December 29, 2019. In this way, all employees were provided with accident insurance,

Further, 15 employees were selected for private interviews from different workshops. No negative comment was issued during employee interviews. Interviewed employees were satisfied with the working environment, compensation, working hour and management team in the factory.

A closing meeting was held with the factory representatives and all of the findings were discussed. Ms. Xiao Yanbo/Deputy General Manager, Ms. Zhang Lizhen/Worker representatives attended the open meeting and the closing meeting. Ms. Xiao Yanbo/Deputy General Manager signed the onsite CAP and agreed to take corrective actions.

1. There was no agency or contracted worker used, no collective bargaining agreement was signed and no government waiver was obtained, either. Thus, no photo attached for the relevant documents.




