三、我们如何留存您的信息

I. How do we collect your information:

We will collect the personal information of the correspondent person at your company that you have directly provided to us, including his/her name, correspondence phone number and email address.

II. How do we use your information:

We will use your information for the following purposes:

1. To send payment notice to suppliers so that suppliers can timely obtain information and practice account reconciliation;
2. Regarding suppliers with notes payment, after our company completes the preparation of payment notes, we will timely inform suppliers about the venue for notes pick-up;
3. Supplier Account Reconciliation: our company will send account reconciliation request to suppliers email to complete account reconciliation/account check, so as to improve the business transparency and the cooperation relationship between suppliers and our company.

These information will be accessed and used by HUAWEI affiliated companies that have contract relationship with your company.

III. How do we keep your information:

The personal information collected in Confirmation Letter with Supplier Bank Information will be kept and processed in the region of your company, and in other countries/regions of HUAWEI TECHNOLOGIES CO., LTD., HUAWEI's affiliated companies, subsidiary companies or other service provider organizations. We have set up data center in the United Kingdom, Russia and China. Your data will be kept in the server that is the closest to your region.

HUAWEI affiliated company, which has contract relationship with your company and processes the collected information, will be the data controller of the personal information collected through this statement.
